

2013 Sony Open Tennis Follow Click Win Sweepstakes

1. **Eligibility:** The Sony Open Tennis Follow Click Win Contest (the "Sweepstakes") is open only to individuals who (a) are legal residents of the United States, (b) are at least eighteen (18) years of age or the age of majority in their jurisdiction of residence, whichever is older, and (c) have an Instagram & Twitter account. Employees of Sony Open Tennis, Sony, Mobile Communications, Sony Corporation or other companies associated with the Sweepstakes (including any advertising and promotion agencies), and their respective parent companies, affiliates and subsidiaries as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee, whether or not related, are not eligible to enter. The Sweepstakes is subject to all applicable laws and regulations and is void outside the United States, in Alaska and Hawaii and where prohibited.
2. **Sponsor:** The Sweepstakes is sponsored by Sony Open Tennis, 1500 Douglas Rd Suite 230, Coral Gables, FL 33314 ("Sponsor"). Instagram, Facebook, Twitter & Pinterest are not affiliated with this Sweepstakes.
3. **Agreement to Official Rules:** By entering the Sweepstakes, entrant indicates his/her full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor's decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
4. **Entry Period:** The Sweepstakes will take place on March 29, 2013 from approximately 12:01 AM Eastern Time ("ET") to 11:59 PM ET, March 31, 2013 ("Entry Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
5. **How to Enter:** If you don't already follow Sony Open Tennis on Instagram/Twitter, visit <http://instagram.com/SonyOpenTennis> & <http://twitter.com/sonyopentennis> and click on the icon to follow the Sony Open Tennis. Once you have signed up to follow the Sony Open Tennis, to enter, simply engage with us on Instagram by following us and posting an original tennis related photo of the 2013 Sony Open Tennis Site during the contest period for your chance to win a prize. During the entry period contestants must use the #FansView hashtag with each original posted image then share it on their twitter account. If you post updates to or receive updates from Instagram/Twitter via SMS from your wireless phone, your wireless service provider may charge you for each text message you send and receive. Please consult your wireless service provider for more information. Sponsor is not responsible for any charges wireless service provider may charge entrant. All terms and conditions of Instagram.com apply. Multiple entrants are not permitted to share the same Instagram account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Instagram accounts, identities, registrations, or logins, or through any other methods, may void all of that entrant's entries and that entrant may be disqualified. The use of any automated system to enter or subvert the entry process the Sweepstakes is prohibited and may result in disqualification.
6. **Winner Selection:** During the Entry Period, the Sony Open Tennis will randomly select a total of two (2) eligible individuals who engage with the Sony Open Tennis (as described above) as potential winners. The first winner will be selected March 29th, 2013 at approximately 11pm ET. The second winner will be selected April 1, 2013 at approximately noon ET.

The odds of being selected depend on the number of eligible individuals who engage with the Sony Open Tennis during the Entry Period.

7. **Notification and Requirements of Potential Winner:** Potential winners will be announced during the Entry Period as they are selected. An individual is not deemed a winner unless and until he/she has complied with these Official Rules regardless of whether he/she has been announced as a winner on Instagram/Twitter or in any other forum. The Sponsor will also send the potential winner a message from @SonyOpenTennis to the potential winner's Instagram account used to enter the Sweepstakes with instructions on how to claim the prize. The winner's photo will also be featured on Sony Open Tennis', Pinterest, Facebook Page status updates, Twitter & Instagram. In order to receive a message from Sponsor, Entrant must (a) be following @SonyOpenTennis and (b) have his or her account settings set to "unprotected" and/or "public." 8. Sponsor reserves the right to not award all prizes if, in its sole discretion, an insufficient number of eligible individuals engage with the Sony Open Tennis on Instagram during the Entry Period. Prizes are awarded "as is" with no warranty or guarantee, either express or implied. Smartphone activation, data, and/or calling plan costs are not included and are the sole responsibility of the winner. Prizes are not transferable and must be accepted as awarded. Winners may not request cash or other substitution; however, the Sponsor reserves the right to substitute a prize with another prize of comparable or greater value, in its sole discretion. All prize details will be determined by Sponsor in its sole discretion. Winner is responsible for any local, state, and/or federal taxes associated with receiving a prize.
9. **General Conditions:** Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Sweepstakes in the event that the operation, security, or administration of the Sweepstakes is impaired in any way, including, but not limited to by fraud, virus, unauthorized human intervention or other technical problem.
